



CLUB RULES

A. DRESS CODE (GOLF COURSE)

- APPROPRIATE GOLF ATTIRE SHOULD BE WORN AT ALL TIMES.
- DENIM SHORTS, DENIM PANTS, SLEEVELESS SHIRTS & DENIM SKIRTS ARE NOT ALLOWED IN GOLF COURSE AND WITHIN THE PREMISES
- METAL SPIKES ARE NOT ALLOWED
- MEN'S SHIRTS MUST HAVE COLLARS & SLEEVES. MOCK TURTLENECK SHIRTS MUST HAVE AT LEAST ONE(1) INCH COLLAR

B. DRESS CODE (VERANDA & OTHER CLUB FACILITIES)

- JERSY, SLEEVELESS SHIRT (SANDO), SIMILAR ATHLETIC WEAR & SWIM WEAR ARE NOT ALLOWED

C. TEE TIME RESERVATIONS

- TEE TIME RESERVATION IS **MANDATORY**.
- RESERVATION (PHONE-IN OR PERSONAL) CAN BE MADE **THREE (3) DAYS IN ADVANCE**.
- CANCELLATION MUST BE MADE WITHIN **12 HOURS BEFORE** THE PLAYING DATE, OTHERWISE THE MEMBER WILL BE CHARGED A **"NO-SHOW" FEE OF PHP1, 500.00** FOR WEEKDAYS AND **PHP3, 000.00** FOR WEEKENDS AND HOLIDAYS.
- THE **ONE-MEMBER-PER-FLIGHT RULE IS STRICTLY ENFORCED**.
- FLIGHTS WITHOUT MEMBERS WILL BE CHARGED THE PREVAILING UNACCOMPANIED RATE.
- FLIGHTS MUST BE AT THE STARTERS' AREA **TEN (10) MINUTES BEFORE** TEE TIME.
- FLIGHTS LATE FOR TEE TIME WILL BE RELEGATED TO THE LAST SLOT/VACANT SLOT IN THE TEE TIME SCHEDULE.
- ONESOME (1) AND TWOSOME (2) ARE NOT ALLOWED DURING WEEKENDS AND HOLIDAYS.
- **FIVESOMES (5)** ARE ALLOWED PROVIDED THAT THEY HAVE AT LEAST **TWO (2) CARTS** AND THE **TOTAL HANDICAP** OF THE 5 PLAYERS DOES NOT EXCEED 90.
- **ONE (1) TEE TIME RESERVATION IS GOOD FOR ONE (1) FLIGHT ONLY.**

- MANAGEMENT RESERVES THE RIGHT TO COMBINE FLIGHTS OF LESS THAN FOUR (4).

D. GOLFCART RULES

- **A MAXIMUM OF THREE (3) PERSONS MAY RIDE THE CART (2 SEATER)**
- PLAYERS MUST REMAIN SEATED WHILE THE CART IS MOVING. RIDING IN THE REAR (GOLF BAG CARRIER) OF THE CART IS NOT ALLOWED.
- PLAYERS WITH CARTS ARE EXPECTED TO FOLLOW THE POSTED CART RULES ALONG THE COURSE.
- ADULTS (18 & ABOVE) ARE PERMITTED TO RENT AND OPERATE A GOLF CART.
- GOLF CARTS SHOULD BE USED INSIDE THE GOLF COURSE AND GOLF CART PARKING AREA ONLY.
- MEMBERS ARE NOT ALLOWED TO BRING AND USE PRIVATE GOLF CARTS INTO THE CLUB PREMISES WITHOUT PRIOR APPROVAL OF MANAGEMENT.

E. GUEST

- MEMBERS OF THE CLUB SHALL BE ENTITLED TO ENTERTAIN GUESTS AT THE CLUB, SUBJECT AT ALL TIMES HOWEVER, TO SUCH RULES AND REGULATIONS AND GUEST FEES AS MAY ESTABLISHED BY THE CLUB MANAGEMENT FROM TIME TO TIME. MEMBERS WILL BE HELD LIABLE FOR ANY DAMAGES TO PROPERTY CAUSED BY HIS/HER GUEST/S.

F. FOOD & BEVERAGES

- MEMBERS AND GUESTS ARE NOT ALLOWED TO BRING INTO THE CLUB PREMISES ANY FOOD OR DRINKS NOT PURCHASED FROM THE CLUB. CORKAGE FEE IS P2, 500.00 PER ITEM.
- MEMBERS AND GUESTS ARE NOT ALLOWED TO PURCHASE FOOD AND DRINKS AT THE CADDIES CANTEEN.

G. MEMBERSHIP ID SYSTEM

- ALL MEMBERS, DEPENDENTS AND GUESTS MUST SECURE A BAG TAG FROM THE BAG DROP AREA (GAZEBO) AND MUST BE PRESENTED AT THE REGISTRATION COUNTER.
- GREEN FEES (FOR GUESTS), CART RENTAL FEES, AND F & B CONSUMPTIONS IN THE CLUBHOUSE AS WELL AS IN THE TEE HOUSES ARE POSTED. UPON CHECK OUT AT THE REGISTRATION COUNTER, THE PASSPORT MUST BE PRESENTED AND ALL EXPENSES MUST BE SETTLED IN ORDER TO SECURE THE BAG TAG. MEMBERS AND THEIR GUESTS CAN SETTLE THEIR ACCOUNTS EITHER BY CASH OR USING MAJOR CREDIT CARDS. BAG TAGS ARE PRESENTED TO THE BAG

PORTER AT THE BAG DROP AREA IN ORDER TO RETRIEVE YOUR GOLF BAG.

- FAILURE TO BRING MEMBERSHIP ID, THE CLUB WILL ISSUE A NEW MEMBERSHIP ID AMOUNTING TO P300.00.
- MEMBERS WHO OPTED TO DINE ONLY STILL NEED TO BRING AND PRESENT THE MEMBERSHIP ID TO THE RECEPTION OR F&B SERVICE STAFF IN ORDER TO PROCESS THE DINING DAYPASS/PASSPORT PRIOR ORDERING FOOD OR BEVERAGES AT THE VERANDA. POLICY ON “NO DAYPASS, NO FOOD & BEVERAGE TRANSACTIONS WILL BE ENTERTAINED”

H. STAFF AND CADDIE DISCIPLINE

MATTERS OF STAFF AND CADDIE DISCIPLINE ARE THE RESPONSIBILITY OF CLUB MANAGEMENT. NO MEMBERS OF THE CLUB, OR ANY MEMBER OF ITS FAMILY OR GUESTS, SHALL BE PERMITTED TO REPRIMAND, DISCIPLINE OR ABUSE, VERBALLY OR OTHERWISE. UNSATISFACTORY SERVICE SHOULD BE REPORTED TO THE CLUB MANAGEMENT IMMEDIATELY. ALL COMPLAINTS SHOULD BE MADE IN WRITING.

I. DAMAGE TO GREENS

ANY DAMAGE TO THE GREENS, WHETHER INTENTIONAL OR UNINTENTIONAL WILL BE CHARGED FIVE THOUSAND PESOS (**PHP5,000.00**). REPETITION OF THIS OFFENSE WILL BE CHARGED ANOTHER FIVE THOUSAND PESOS AND A REPORT WILL BE FORWARDED TO THE MEMBERSHIP COMMITTEE TO REVIEW.

J. BODYGUARDS / PERSONAL ASSISTANT / DRIVERS

BODYGUARDS, ASSISTANTS AND DRIVERS ARE NOT ALLOWED INSIDE THE LOCKERS. THEY CAN ONLY STAY IN DESIGNATED WAITING AREAS. BODYGUARDS ARE NOT ALLOWED TO BRING FIREARMS INSIDE THE CLUB PREMISES. FIREARMS MUST BE SURRENDERED TO THE LOBBY GUARD FOR SAFEKEEPING IN EXCHANGE OF CLAIM STUB.

K. FIREARMS

MEMBER/GUEST IS NOT ALLOWED TO BRING FIREARMS INSIDE THE PREMISES. FIREARMS MUST BE SURRENDERED TO THE LOBBY GUARD FOR SAFEKEEPING. FIREARM LICENSE MUST BE SHOWN FOR SECURITY REASON AND RECORDING PRIOR ISSUANCE OF CLAIM STUB. ITEMS TO BE RECORDED ARE THE FOLLOWING: FIREARM LICENSE CARD, CONTROL NUMBER, KIND/MAKE, MODEL/CALLIBER/SERIAL NUMBER OF THE SAID FIREARM. THE LOBBY GUARD THEN WILL RETURN THE FIREARM LICENSE IN EXCHANGE OF CLAIM STUB.

L. CLUB FEES AND ASSESSMENTS

MEMBERS ARE LIABLE TO PAY ALL EXPENSES AND CHARGES SUCH AS MONTHLY DUES, PARKING FEE (IF APPLICABLE), HANDICAPPING FEE, CADDY FEES, CART RENTALS, ASSESSMENTS AND OTHER CLUB EXPENSES RELATED TO OR CONNECTED WITH THE USE OF ASSIGNED PLAYING RIGHTS.

M. SWIMMING POOL

EASTRIDGE SWIMMING POOL RULES AND REGULATIONS

- CLUB SWIMMING POOL OPENS FROM 6:00AM – 6:00PM FROM TUESDAY TO SUNDAY.
- MEMBERS, DEPENDENTS AND MEMBER'S GUESTS ARE ALLOWED TO USE THE SWIMMING POOL.
- RESERVATION SHOULD BE MADE BY THE MEMBER AT LEAST 24 HOURS IN ADVANCE.
- ONLY DEPENDENT/S OF MEMBERS DECLARED ON THE APPLICATION FORM IS FREE OF CHARGE. (PRIMARY MEMBERS – SPOUSE + DEPENDENTS BELOW 25 YEARS OLD; INDIVIDUAL ASSIGNEE – SPOUSE + WIFE)
- GUESTS/NOT QUALIFIED DEPENDENTS OF MEMBERS WILL BE CHARGED A FEE OF P200.00 PER HEAD.
- MEMBER'S GUESTS ARE ONLY ALLOWED TO TAKE A SHOWER AT THE POOL SHOWER ROOM.
- THE MEMBER/S, HIS/HER DEPENDENTS AND HIS/HER GUESTS MUST REGISTER AT THE FRONT DESK PRIOR USE OF POOL.
- LOITERING ON SWIMSUIT ON OTHER AREA OR FACILITIES OF THE CLUB IS NOT BE PERMITTED
- THE MANAGEMENT PROHIBITS BRINGING IN FOOD AND DRINKS IN ANY AREA OF THE CLUB INCLUDING IN THE SWIMMING POOL AREA NOT PURCHASED FROM THE CLUB RESTAURANT. APPROPRIATE CORKAGE FEE PER ITEM WILL BE CHARGED.
- FOOD OR REFRESHMENTS ARE CONSUMED ONLY AT THE DESIGNATED SEATING AREAS. EATING/DRINKING AT THE POOL IS NOT ALLOWED.
- THE MEMBER WILL BE HELD LIABLE FOR ANY DAMAGE TO PROPERTY CAUSED BY HIS/HER DEPENDENTS AND GUESTS.
- PETS ARE NOT ALLOWED INSIDE THE PREMISES

- MEMBERS/GUESTS MUST BE ATTIRED IN SWIMMING APPAREL. (DISPOSABLE DIAPER IS NOT ALLOWED)
- NO PERSON WITHIN THE POOL AREA SHALL BEHAVE IN SUCH A MANNER AS TO JEOPARDIZE THE SAFETY AND HEALTH OF SELF AND OTHERS. SUCH BEHAVIOR, INCLUDING ABUSIVE OR PROFANE LANGUAGE, SHALL BE GROUNDS FOR EXPULSION
- ROUGH PLAY, PUSHING, ACROBATICS, WRESTLING, YELLING, DIVING WITHOUT CARE AND CAUTION, IMPROPER CONDUCT CAUSING UNDUE DISTURBANCES ON THE POOL AREA OR ANY ACTS WHICH WOULD ENDANGER ANY PATRON IS PROHIBITED.
- SPITTING, URINATING, BLOWING NOSE, DEFECATING IN THE POOL IS PROHIBITED
- CHILDREN UNDER 12 YEARS OLD MUST BE ACCOMPANIED BY AN ADULT
- ANY PERSON WITH SKIN DISEASE, SORE OR INFLAMED EYES, COLD, NASAL OR EAR DISCHARGE, COMMUNICABLE DISEASE OR WHO IS WEARING ANY KIND OF BANDAGE OR BAND-AID TO COVER OPEN (UNHEALED) WOUNDS WILL NOT BE PERMITTED IN THE POOL.
- ANY INJURY OCCURRING IN THE POOL MUST BE REPORTED TO THE LIFEGUARD OR TO ANY CLUB PERSONNEL IMMEDIATELY.
- TAKE A SHOWER BEFORE GETTING INTO THE POOL.
- DO NOT LEAVE VALUABLES UNATTENDED. THE CLUB IS NOT RESPONSIBLE FOR LOSS OF ANY PERSONAL PROPERTY OR VALUABLES.
- IT IS THE DISCRETION OF THE MANAGEMENT TO CLOSE THE POOL OPERATION ANYTIME.
